## MDTi welcomed as one of Britain's best SME's at the Birmingham briefing and Commonwealth Export Champion interviews

The CommonwealthFirst initiative organised a briefing on April 25th hosted by Birmingham Airport and sponsored by Turkish Airlines to raise awareness of its SME export champions programme and invite further applicants from small firms, which have high growth and international trading potential. Participants included SMEs, journalists, local and regional government representatives, and HE Kena Mphonda, the Malawi High Commissioner to the UK.

The regional event highlighted the many opportunities and benefits of trading within the Commonwealth as well as recruitment for the third cohort of Commonwealth Export Champions, which opened at the Trade Ministers Meeting last month. The previous intake of SME cohorts participated in a trade mission during the India-UK Tech Summit, Delhi last November which coincided with Theresa May's first overseas visit as prime minister. The second trade mission is scheduled for Malaysia and Singapore between 14th -18th May 2017.

CommonwealthFirst is the brainchild of the Commonwealth Enterprise and Investment Council (CWEIC) with Royal Mail as lead sponsor and i-genius as implementation partner. Its mission is to encourage and support small and medium enterprises to trade and invest across the Commonwealth.

Lord Marland, the Chairman of the Commonwealth Enterprise & Investment Council (CWEIC), said, "At a time when trade is under the spotlight, it is encouraging to see such high-quality export-ready small businesses that are coming forward to take part in this ambitious programme."

### **Prof. Jim Richards Latest Published Paper**

A paper has been published in the Journal of Human Kenetics - vol 52/2016, 125 – 138 called 'The Effects of Different Decline Angles on the Biomechanics of Double Limb Squats and the Implications to Clinical and Training Practice', by Jim Richards, Professor of Biomechanics; Professor James Selfe, Jonathan Sinclair, Karen May, Gavin Thomas, Allied Health Research Unit, University of Central Lancashire, Preston, UK.

The RehabAngel adjustable incline/decline rehabilitation device, an MDTi product, invented by Neil Frame a Podiatrist based in Maccelsfield, was used to perform the five double limb squats described in the paper. The paper concludes ' this investigation indicates that using a graduated decline squat angle offers knee rehabilitation that allows a graduated increase in the load applied to the knee and graduated reduction in ankle moments and forces as the decline angle increases, with an optimum angle of between 15-20 degrees, which is less than the decline angles previously used in rehabilitation. Using a range of decline squat angles allows clinicians to be able to offer a controlled graduated rehabilitation environment for squatting tasks. This may also be useful in athletic training due to the greater work done by the quadriceps. This paper provides normative data to compare with individuals in recovery programs and has the potential to be used in physical conditioning and possible avoidance of overload.
